All incidental skin contact, including: Machine Dish wash Detergents and Deodorizers. Machine only Laundry Detergents (e.g. liquid tabs) Deodorizers/Maskers (e.g. fabric drying machine deodorizers, carpet powder) Pot pourri, fragrancing sachets, liquid refills for air fresheners (non-cartridge systems), etc... Shoe polishes; Cat Litter; Animal Sprays (excluding aerosols); Treated Textiles (e.g. starch sprays, fabric treated with fragrances after wash, deodorizers for textiles or fabrics, tights with moisturizers); Odored Distilled Water (that can be added to steam irons)	Class 11.B
