Shoe polishes; Cat Litter; Animal Sprays (excluding aerosols); Treated Textiles (e.g. starch sprays, fabric treated with fragrances after wash, deodorizers for textiles or fabrics, tights with moisturizers); Odored Distilled Water (that can be added to steam irons)	Class 11.B
